Trends in Septicemia Hospitalizations and Readmissions in Selected HCUP States, 2005 and 2010

Introduction

Septicemia, commonly referred to as sepsis, is a serious blood infection that produces systemic inflammation and may lead to organ failure, shock, and even death. Most often caused by bacteria or bacterial toxins in the blood stream (bacteremia with sepsis), more than one million cases of septicemia are reported in the United States each year.¹ Costs of septicemia treatment are high, with total hospital costs estimated to be more than \$24 billion in 2007.² Despite resources incurred in treatment, an estimated 25 to 50 percent of patients succumb to this condition, making septicemia the tenth leading cause of death in the United States.³

Hospitalizations associated with septicemia have risen markedly over the past decade. A study conducted by the Agency for Healthcare Research and Quality (AHRQ) found that between 2000 and 2009, the number of hospitalizations with a principal diagnosis of septicemia increased by 148 percent, and hospitalizations with a secondary diagnosis of septicemia increased by 66 percent. In fact, septicemia was the sixth most common principal diagnosis in the inpatient setting, accounting for one out of every 23 hospitalized patients.⁴

This Statistical Brief builds on comparisons between 2000 and 2009 data on septicemia-related hospitalizations that were presented in a previous report⁴ by examining trends in septicemia hospitalizations for 2005 and 2010. It focuses on the subpopulation with two or more septicemia admissions during the

Highlights

- Across selected States, there was a 32 percent increase in the rate of septicemia hospitalizations between 2005 and 2010. Rates increased from 492 per 100,000 population to 651 per 100,000 population.
- In 2010, approximately 354,000 individuals were hospitalized one or more times with a septicemia diagnosis.
- In 2010, approximately 16 percent of people with a septicemia hospitalization were admitted two or more times for treatment of septicemia within a 1-year period, compared to 11.5 percent in 2005.
- Average length of stay for patients with one admission with a principal septicemia diagnosis decreased from 9.3 to 8.3 days between 2005 and 2010. There were no significant changes in average length of stay for the index admission for patients with multiple admissions.
- Among patients admitted with septicemia as a principal diagnosis, a much higher proportion of those with a subsequent readmission had been discharged to a long-term care facility. In 2010, 46.8 percent of patients with a readmission were initially discharged to a long-term care facility, compared to 24.6 percent of patients who were not readmitted during the year.
- Individuals admitted from a skilled nursing facility with septicemia were more likely to die during the hospitalization.

year. Seven geographically diverse States are included in these analyses: Arizona, California, Florida, Nebraska, New York, Utah, and Washington.

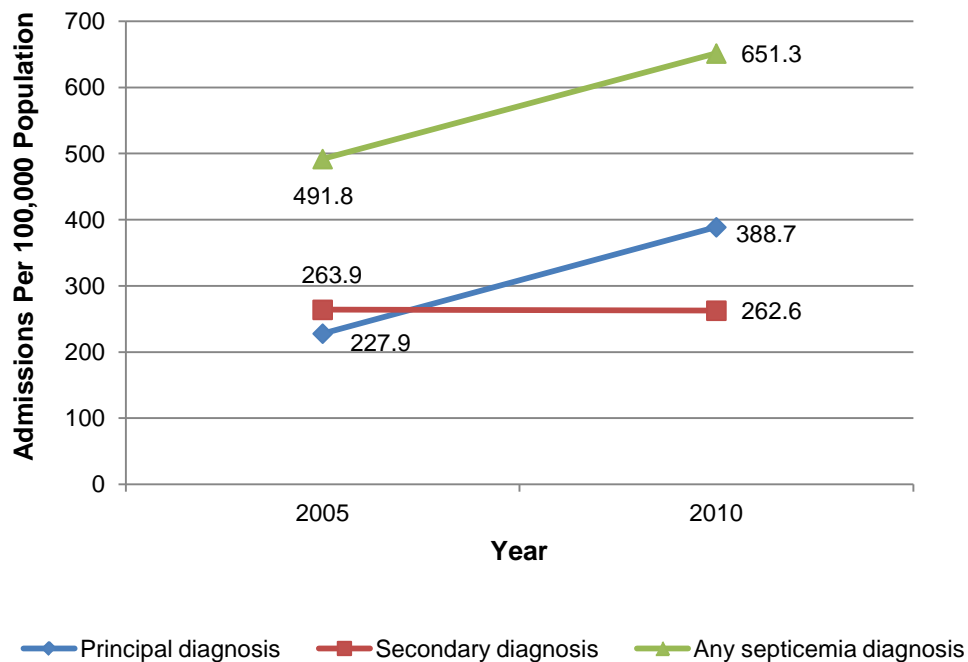
In addition to describing growth in the number of septicemia hospitalizations, this analysis provides estimates of the number of distinct individuals with a septicemia hospitalization and the number of individuals with multiple septicemia admissions during the year. Changes in the number of admissions, characteristics of patients, average length of stay, and discharge disposition are examined for patients with one hospital stay for septicemia and compared to those with multiple septicemia hospitalizations, using data from the Healthcare Cost and Utilization Project (HCUP) State Inpatient Databases (SID). Estimates of average length of stay and discharge disposition for the subgroup with more than one hospitalization are made in reference to the index (initial) hospitalization. Unless otherwise stated, differences between estimates noted in the text are statistically significant at the 0.05 level or better.

Findings

Septicemia admissions

In 2010, hospital admissions with a principal or secondary septicemia diagnosis approximated 651.3 per 100,000 population. This represents a greater than 32 percent increase relative to 2005, when the rate of septicemia admissions was estimated at 491.8 per 100,000 population. As shown in Figure 1, almost all of this increase was due to admissions where septicemia was the principal diagnosis. Between 2005 and 2010, the number of admissions with a principal septicemia diagnosis increased by nearly 71 percent— from a rate of 227.9 per 100,000 population to a rate of 388.7 per 100,000 population.

Figure 1. Septicemia admissions per 100,000 population for patients aged 18 years and older in selected States, 2005 and 2010

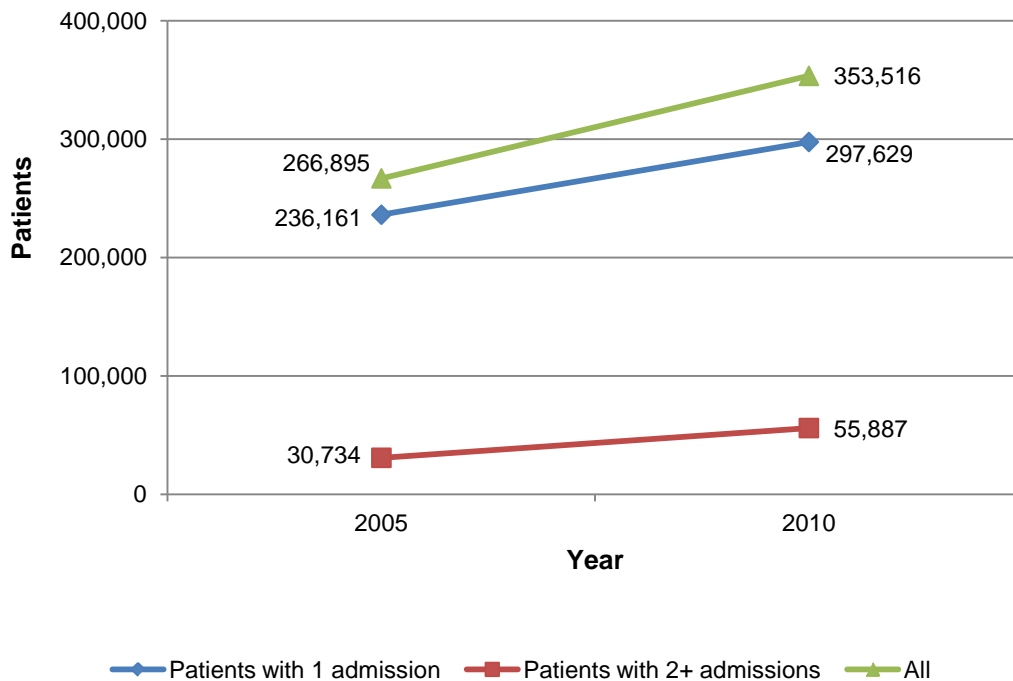

Number of individuals with a septicemia admission

The number of *individuals* with a septicemia-related hospital admission—either as a principal or a secondary diagnosis—increased from 267,000 in 2005 to 354,000 in 2010, which is a growth of approximately 33 percent. In both 2005 and 2010, the vast majority of patients experienced only one admission with a septicemia diagnosis during the year. As shown in Figure 2, in 2005 only 11.5 percent of patients (a total of 30,734) had multiple septicemia admissions during the calendar year compared to 15.8 percent of patients in 2010 (a total of 55,887).

*Includes hospitalizations where septicemia is a principal or secondary diagnosis

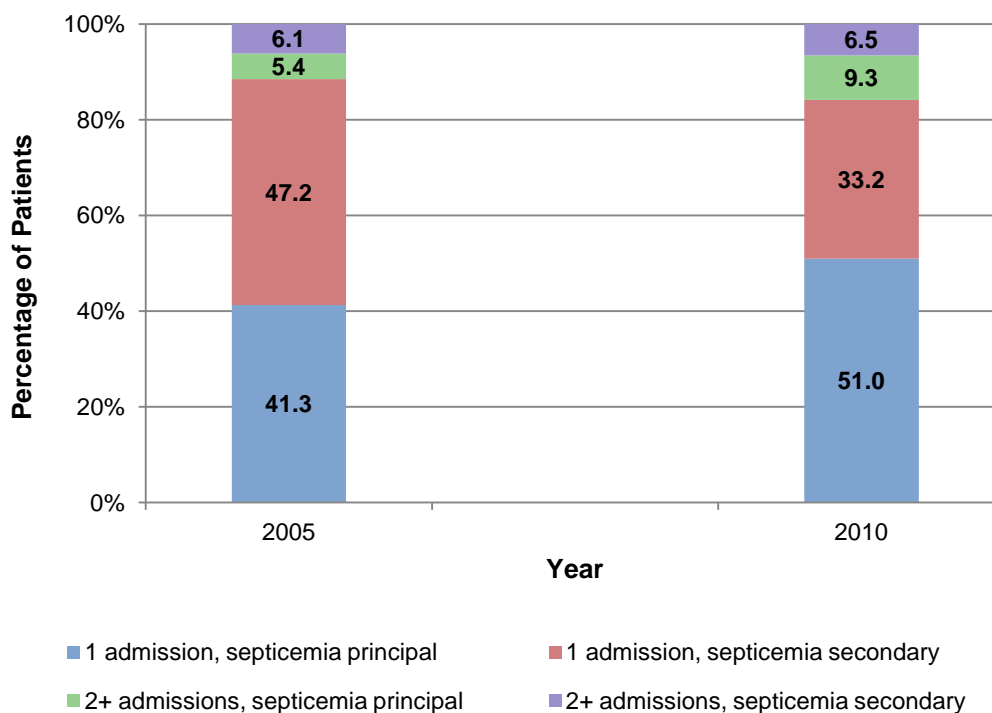

Trends in number of septicemia admissions for septicemia as a principal or secondary diagnosis

Trends in the proportion of individuals with one or multiple septicemia admissions differed by whether septicemia was the principal or secondary admitting diagnosis. As shown in Figure 3, between 2005 and 2010 the proportion of individuals with one septicemia admission where septicemia was the principal diagnosis increased from 41.3 percent to 51.0 percent—a growth of 23 percent. During the same time period, the proportion of individuals with two or more admissions for which septicemia was the principal diagnosis increased from 5.4 percent to 9.3 percent—a growth of 72 percent.

Among those with a septicemia secondary diagnosis, the proportion with one admission decreased from 47.2 percent to 33.2 percent—a decline of 30 percent. No difference was observed in the proportion of individuals with multiple admissions when septicemia was the secondary diagnosis during the index stay.

Characteristics of patients with multiple septicemia admissions

As shown in Table 1, there were larger differences between patients with a principal versus a secondary septicemia diagnosis than between patients with one versus multiple septicemia admissions. Among the subgroup with a septicemia principal diagnosis, equal proportions—approximately one-fifth—of those with one admission and those with multiple septicemia admissions were 85 years of age or older. However, among those with a secondary septicemia diagnosis, only 14.1 percent with one admission and 11.5 percent with multiple admissions were in this age group. Approximately one-half of admissions with a diagnosis of septicemia were female.

Medicare was the expected primary payer for a greater proportion of individuals with multiple septicemia admissions than for those with a single admission. Among patients for which septicemia was a principal diagnosis, 68.5 percent of patients with one admission were insured by Medicare, compared to 74.3 percent of those with multiple admissions. Almost two-thirds of patients with a septicemia admission were covered by Medicare.

Thirty-day readmissions

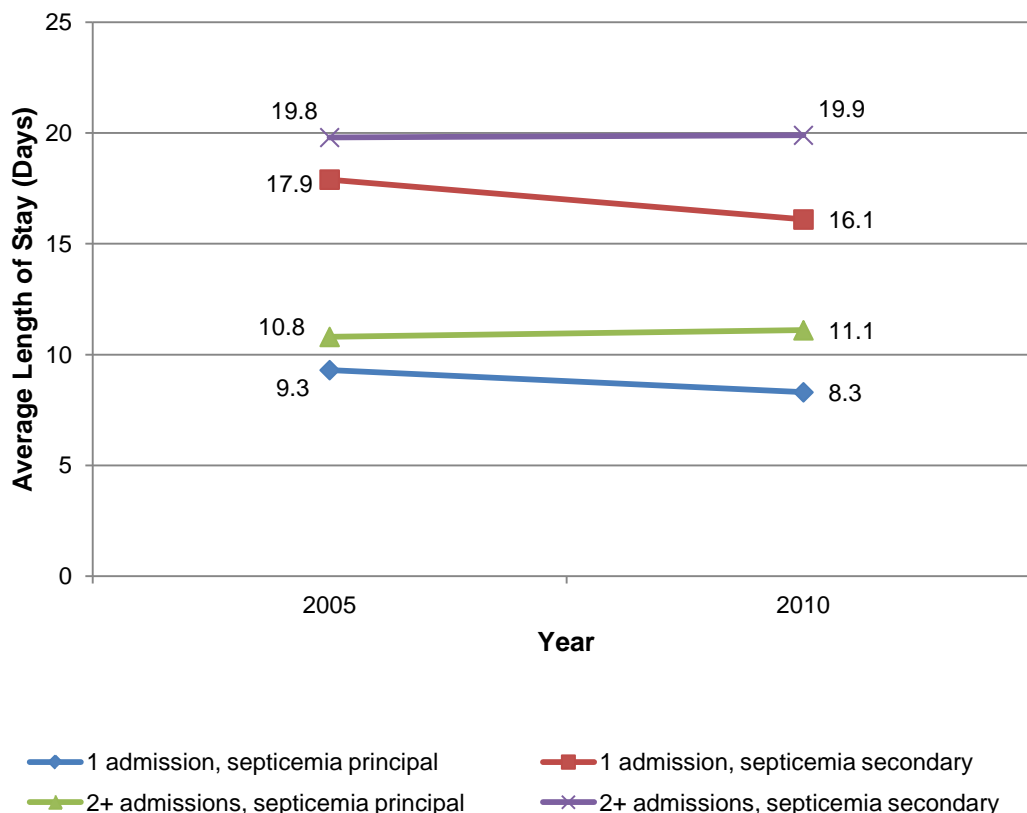
Among patients readmitted after a stay with septicemia as the principal diagnosis, 51.5 percent were readmitted within 30 days in 2005 compared to 62.3 percent readmitted within 30 days in 2010—a 21 percent *increase* (data not shown). Among those readmitted following an index stay with a secondary septicemia diagnosis, the proportion readmitted within 30 days decreased from 48.5 percent in 2005 to 37.7 percent in 2010—a *decrease* of 22 percent.

Trends in average length of stay

Figure 4 provides information on the average length of stay for patients admitted with a principal and secondary septicemia diagnosis. As indicated on this figure, average length of stay declined by 1 day (from an average of 9.3 to 8.3 days) for patients with one admission where septicemia was the principal diagnosis. Among patients with only one admission where septicemia was a secondary diagnosis, length of stay declined by almost 2 days from an average of 17.9 days in 2005 to 16.1 days in 2010.

For the subset of patients with multiple septicemia admissions, length of stay was examined for the index admission. Regardless of whether septicemia was a principal or secondary diagnosis, between 2005 and 2010 no significant differences in average length of stay for the index admission were observed for the subgroup of patients who experienced multiple admissions during the year.

Discharge disposition

As shown in Table 2, patients with multiple admissions for septicemia were more likely to be discharged to a skilled nursing facility (SNF) or long-term care (LTC) following the index hospitalization. In 2010, for example, 46.8 percent of patients with a principal septicemia diagnosis who would later have another admission had been discharged to a SNF or LTC following their index stay. In contrast, only 24.6 percent of patients with a principal septicemia diagnosis who were not readmitted during the subsequent year had been discharged to a SNF or LTC.

Admission source

Regardless of whether septicemia was a principal or secondary diagnosis, a greater proportion of patients with one septicemia admission were admitted from a SNF (data not shown). For the subgroup with a septicemia principal diagnosis, 3.7 percent of patients with one hospitalization had been admitted from a SNF compared to 2.2 percent of those with multiple subsequent septicemia admissions. For the subgroups with a septicemia secondary diagnosis, 5.3 percent of patients with one hospitalization and 2.9 percent of those with multiple hospitalizations had been admitted from a SNF.

Individuals admitted from a SNF were more likely to die during their hospitalization than those admitted from the community or other setting (data not shown). In 2010, 28.0 percent of patients admitted from a SNF died during the hospitalization compared to 19.8 percent of those admitted from other settings.

Note

Coding practices may have changed in the time period covered by this study. The extent to which these changes may have affected observed trends is unclear.

Data Source

The estimates in this Statistical Brief are based upon a readmission analysis file created using the Healthcare Cost and Utilization Project (HCUP) 2005 and 2010 State Inpatient Databases (SID) from seven States: Arizona, California, Florida, Nebraska, New York, Utah, and Washington. States were selected based on the availability of reliable, verified synthetic patient identifiers that can be used to track a person across time and hospitals.

Definitions

Diagnoses, ICD-9-CM, and Clinical Classifications Software (CCS)

The *principal diagnosis* is that condition established after study to be chiefly responsible for the patient's admission to the hospital. *Secondary diagnoses* are concomitant conditions that coexist at the time of admission or that develop during the stay. For purposes of this study, admissions with a principal and secondary septicemia diagnosis are classified as principal septicemia in order to avoid double counts.

ICD-9-CM is the International Classification of Diseases, Ninth Revision, Clinical Modification, which assigns numeric codes to diagnoses. There are about 14,000 ICD-9-CM diagnosis codes.

CCS categorizes ICD-9-CM diagnoses into a manageable number of clinically meaningful categories.⁵ This "clinical grouper" makes it easier to quickly understand patterns of diagnoses. CCS categories identified as "Other" are typically not reported; these categories include miscellaneous, otherwise unclassifiable diagnoses that may be difficult to interpret as a group.

Case definition

Admissions with a septicemia diagnosis were identified as those with a single-level CCS diagnosis category = 2, and included the following ICD-9-CM codes: 003.1, 020.2, 022.3, 036.2, 038.0, 038.1, 038.10, 038.11, 038.12, 038.19, 038.2, 038.3, 038.40, 038.41, 038.42, 038.43, 038.44, 038.49, 038.8, 038.9, 054.5, 449, 771.81, and 790.7.

Because the algorithm that individual States use to generate encrypted identifiers may vary across years, it was not possible to track individuals over a fixed window of time. Therefore, analyses were limited to individual experiences during calendar year 2005 and 2010.

Readmissions

Any cause 30-day readmissions were identified as any admission that occurred up to 30 days following discharge for the index hospitalization. In other words, patients with a septicemia index hospitalization who were discharged alive were followed for a period of 30 days. If another admission to the same or a different hospital (for any diagnosis) occurred during this time period, a readmission indicator was set to "1". If more than one discharge occurred during this time frame, only one readmission was counted. Transfers to another hospital that occurred on the same day as the discharge for the index admission were not counted as a readmission.

Multiple (2+ septicemia admissions)

Individuals with multiple septicemia admissions were identified as any patient with a principal or secondary septicemia diagnosis (as appropriate to the analysis) who experienced one or more hospitalizations with a septicemia principal or secondary diagnosis during the calendar year. With the exception that the second admission had to occur during the same calendar year, no restriction was placed on the number of days between the index hospitalization and the following septicemia admission.

Types of hospitals included in HCUP

HCUP is based on data from community hospitals, which are defined as short-term, non-Federal, general and other hospitals, excluding hospital units of other institutions (e.g., prisons). HCUP data include obstetrics and gynecology, otolaryngology, orthopedic, cancer, pediatric, public, and academic medical

hospitals. Excluded are long-term care, rehabilitation, psychiatric, and alcoholism and chemical dependency hospitals. However, if a patient received long-term care, rehabilitation, or treatment for psychiatric or chemical dependency conditions in a community hospital, the admission record for that stay will be included in the Nationwide Inpatient Sample (NIS).

Unit of analysis

The units of analysis in this Statistical Brief are the hospital admission (i.e., the hospital stay) and the person or patient. The former means that a person who is admitted to the hospital multiple times in one year will be counted each time as a separate "admission" to a hospital. The latter means that a person who is admitted to the hospital multiple times during the year is counted only once. Individuals represented in these analyses include those aged 18 years or older.

Payer

Payer is the expected primary payer for the hospital stay. To make coding uniform across all HCUP data sources, payer combines detailed categories into general groups:

- Medicare: includes patients covered by fee-for-service and managed care Medicare
- Medicaid: includes patients covered by fee-for-service and managed care Medicaid
- Private Insurance: includes Blue Cross, commercial carriers, and private health maintenance organizations (HMOs) and preferred provider organizations (PPOs)
- Other: includes Worker's Compensation, TRICARE/CHAMPUS, CHAMPVA, Title V, and other government programs
- Uninsured: includes an insurance status of "self-pay" and "no charge."

Encounters billed to the State Children's Health Insurance Program (SCHIP) may be included here. They may be classified as Medicaid, Private Insurance, or Other, depending on the structure of the State program. Because most State data do not identify SCHIP patients specifically, it is not possible to present this information separately.

When more than one payer is listed for a hospital admission, the first-listed payer is used.

Admission source or point of origin

Admission source (now known as patient's point of origin) indicates where the patient was located prior to admission to the hospital. Emergency admission indicates that the patient was admitted to the hospital through the emergency department. Admission from another hospital indicates that the patient was admitted to this hospital from another short-term, acute-care hospital. This usually signifies that the patient required the transfer in order to obtain more specialized services that the originating hospital could not provide. Admission from a long-term care facility indicates that the patient was admitted from a long-term facility such as a nursing home.

Discharge status

Discharge status reflects the disposition of the patient at discharge from the hospital and includes the following six categories: routine (to home); transfer to another short-term hospital; other transfers (including skilled nursing facility, intermediate care, and another type of facility such as a nursing home); home health care; against medical advice (AMA); or died in the hospital.

About HCUP

HCUP is a family of powerful health care databases, software tools, and products for advancing research. Sponsored by the Agency for Healthcare Research and Quality (AHRQ), HCUP includes the largest all-payer encounter-level collection of longitudinal health care data (inpatient, ambulatory surgery, and emergency department) in the United States, beginning in 1988. HCUP is a Federal-State-Industry Partnership that brings together the data collection efforts of many organizations—such as State data organizations, hospital associations, private data organizations, and the Federal government—to create a national information resource.

The HCUP State Inpatient Databases (SID) are hospital inpatient databases from data organizations participating in HCUP. The SID contain the universe of the inpatient discharge abstracts in the participating HCUP States, translated into a uniform format to facilitate multistate comparisons and analyses. Together, the SID encompass more than 95 percent of all U.S. community hospital discharges in 2009. The SID can be used to investigate questions unique to one State, to compare data from two or more States, to conduct market area variation analyses, and to identify State-specific trends in inpatient care utilization, access, charges, and outcomes.
